Park Profile: Chestnut Ridge

The Jewel of the Erie County Parks

Chestnut Ridge Park features stunning views of downtown Buffalo and Canada, mature woods, grassy meadows, steep ravines, and miles of hiking, ski, and horse trails.

Established in 1926, Chestnut Ridge is one of the 5 original Erie County Parks. It covers 1,231 acres in the town of Orchard Park. In the 1930's, the federal Works Progress Administration built many of the stone features for which the park is now known. The current casino building dates from 1938. It and other structures were made from diseased Chestnut trees that gave the park its name. The seldom-visited Shale Creek Preserve, located in the southwestern section of the park, is home to Eternal Flame Falls.

Ski-O Set for Byrncliff Resort

Byrncliff Resort was voted "Best Cross-Country Skiing in Western New York" by *Buffalo Spree Magazine*. Located off of Route 20A in the town of Varysburg, Byrncliff features 12 miles of groomed trails.
